The meeting was called to order by Mayor Donald Tinari at 6:11 p.m.

In recognition of visitors to the meeting, the Mayor asked them to introduce themselves. They were Councilperson Paul and his wife, Elizabeth Cable of Wyoming, Delaware.

The Mayor followed with leading the Council and visitors in the Pledge of Allegiance and a Moment of Silence and then by a statement that the meeting was properly posted on June 3, 2015.

• Ordinance 04-22-15-046 Clean Hands Ordinance – a requirement that all fees, fines, assessments and financial obligations of all types be paid in full prior to the approval of permits, licenses and service

This Ordinance will clarify the need for all residents and/or property owners to be current in their payments of all monetary obligations due to the Town of Cheswold prior to the issuance of any type of permit, license and/or service. In addition, the Ordinance is so written, that should the Town of Cheswold, in the future, provide sewer, water, electrical or trash pick-up type services, the Ordinance will not have to be revised to require payment of these type of service costs.

#### ITEMS for COMMENT "continued"

• Ordinance 04-01-15-044 Administration of Land Use Ordinance Fees – an explanation for the requirement of payment and administration of Land Use Ordinance Fees that requires applicants to pay for the full services provided by the Town, Town Engineer and/or Town Attorney in situations that costs exceed the minimum amount initially deposited by the applicant.

This Ordinance provides the opportunity for the Town to recoup costs of services provided by Administration, the Town Engineer and/or the Town Attorney that exceeds the minimum payment, (down payment), made by an applicant for a plan review. The Ordinance is required due to the loss of payment from a previous applicant refusing to pay for the total cost of a plan review by the Town Engineer.
