

CODE ENFORCEMENT PROPERTIES

- **30 New Street** Electric is disconnected. Continuing to wait for Town Attorney to advise on best course of action for potential demolition; collection of taxes and/or acquisition of property. **PENDING**
- **33 New Street** Grass violation. Phone numbers for owner Doug Wissman have been disconnected. A certified letter of the violation was sent to the last known address on October 31, 2016. **IN PROGRESS**
- **53 School Lane** The structure has been demolished and the owner of the property has been contacted regarding the removal of the debris. The owner has committed to removing the debris by Wednesday, December 14, 2016 and will place tape around the debris in order to deter children from playing with it. **IN PROGRESS**
- **215 Commerce Street** repairs are progressing slowly. A walk through with the owner, the Building Inspector and Code Enforcement Officer is scheduled for Tuesday, December 6, 2016. **IN PROGRESS**

Leyland Village:

- 30 Leyland Lane Owner has been cited by certified mail and oral citation as well. Some clean-up has been completed by household items and building materials remain in yard. Owner notified that violation will be forwarded to Criminal Justice Court if not cleaned by next week. IN PROGRESS
- Leyland Village Development Sign development has been purchased by new owner. The name of the property is now Blanton Mobile Home Park and a new sign is being acquired. PENDING.
- **School Lane Manhole Repair** Confirmation was received from Kent County Sewer that they are responsible for the repair and restoration of the manhole and roadway on School Lane and they have added the work to their December construction schedule. They anticipate completing the repair before Christmas, 2016. IN PROGRESS
- Main Street Sidewalk Repair Two detailed estimates have been received from contractors. The third estimate was not detailed and prior to the delivery of a detailed estimate, the contractor contacted DelDOT. As a result of the contact a meeting was held with the contractor, DelDOT representatives and our Town Engineer. DelDOT intends to determine if a maintenance contract exists between DelDOT and the Town, as DelDOT installed the original sidewalk. In either case, a resolution has to be developed to accommodate closing the sidewalk for repair and providing a safe walk-around. If a resolution cannot be found, then a 24 hour flagger may be required. **PENDING**

- Town Hall
 - o **Office Re-design** Met with Justin Olear and contracted painter. The painter reviewed he walls and ceilings and stated that the existing walls can be painted. Justin suggests painting the walls and ceilings white, as it will provide the illusion of more space. The electrical contractor is scheduled to visit the site later in the week, to determine if ceiling lighting fixtures can be replaced. It is hoped that recessed lighting can be accomplished. **PENDING**
 - o **PARKING LOT** Notice of No Objection to Record was received from DelDOT on Friday, December 2, 2016 and the plan was recorded with Kent County by our Town Engineer. The Public Notice for bids was also posted in the newspapers and the bids will be opened at Town Hall on January 13, 2017. **IN PROGRESS**
- **CERTIFICATION** Our new Code Enforcement Officer Mike Callender received certification for Mobile Home Inspection on November 9, 2016.

COMMUNITY COMMENTS: The Mayor opened the meeting to the attendees and there is **Nothing to Report.**

COUNCILPERSON COMMENTS:

Vice-Mayor Larence Kirby – stated that in response to a question that was raised at last month's meeting concerning quiet hours for the airport that he had contacted the Delaware River Bay Authority and found that there are no quiet hours at the airport as mandated by the FAA. The Delaware State Aviation Program is administered at the Cheswold Airport and all trainees must fly early mornings, afternoons and evenings in order to obtain their certification. The positive is that all students graduating from the program acquire positions with aviation carriers.

He also stressed the need for someone to volunteer to serve on Council so that Town business can be properly taken care of in the designated manner.

Secretary/Treasurer Theon Callender – informed everyone that the case of the Town of Cheswold vs. the Central Delaware Business Park was presented to the Superior Court Judge on Friday, November 18, 2016. And the Judge has 90 days to respond with a decision. Mr. & Mrs. Hart requested additional information about the case and the Mayor and Ms. Callender explained that the CDBP desires to continue using the 1977 Zoning Code instead of the current and future revisions to the Land Use Ordinance. They were granted a "vested right" to the 1977 code but that decision did not provide the logistics for administering the code, since there were none in the code. The Town has requested the judge to determine if vested rights are eternal and prohibit future Councils from making decisions about property within the park.

MAYOR'S COMMENTS:

Mayor Bob Sine's – thanked everyone for their attendance and apologized for not being in a position to conduct a complete meeting. He emphasized the reason for having a full membership on Council.
