## AN ACT TO AMEND THE TOWN OF CHESWOLD LAND USE ORDINANCE Article 7 – Use Regulations Table 7.2 – Permitted Uses & Structures

Whereas, the Charter - Section 4.2 of the Town of Cheswold provides that the Town Council has the authority to make, adopt, and establish, alter and amend such Ordinances, Regulations, Rules and By-Laws of the Town; and

Whereas, the Planning Commission of the Town of Cheswold has recommended that the Town Council approve an amendment to the Land Use Ordinance of the Town; and

Whereas, the Town Council properly posted notice of a Public Hearing to be hold on Monday, January 5, 2015, at 6:00 pm, in the Cheswold Town Hall, 691 Main Street, Cheswold, Delaware 19936, to accept public comment on the proposed amendments; and

Whereas, such Public Hearing was held as posted and negative comment was not received from the public concerning the proposed amendments; and

Whereas, the Town Council of the Town of Cheswold, approved the amendments by a unanimous vote of the Town Council, at the properly posted monthly Town Council meeting, held on Monday, January 5, 2015, 6:00 pm, in the Cheswold Town Hall, 691 Main Street, Cheswold, Delaware 19936;

**NOW, THEREFORE BE IT ORDAINED,** the Cheswold Town hereby amends Article 7 – Use Regulations; Table 7.2 – Permitted Uses & Structures as follows;

- Require a Site Plan Review in the C-1 Zone for the Motor Vehicle Sales & Services category
- Require a Site Plan Review in the R-1; R-2; R-3; R-4; C-1 and C-2 Zones for the Not Grouped Elsewhere Accessory Uses category

This resolution was duly adopted by a unanimous vote of the Town Council at its regularly scheduled monthly Town Council Workshop meeting, held on Tuesday, January 20, 2015, at 6:00 p.m., in Town Hall at 691 Main Street, Cheswold, Delaware 19936.
