



COPIES AVAILABLE IN TOWN HALL

The Mayor and Town Council are currently developing ordinances to maintain and control the growth of weeds, trees and plant growth within the corporate limits of Cheswold. Also be reviewed are parking regulation and public nuisance ordinances drafted by the Police Department.

There was an introduction of the ordinances at the March Town Council meeting and a content review at the March Town Council Workshop, where suggestions and input were considered and accepted from residents Loretta Clark, Donald Tinari and Lorraine Sine.

The ordinances have been forwarded to Town Attorney Fred Townsend for legal review, corrections and directions. At their return a Public Notice will be published to specify a date, time and place for Town residents to provide additional comments and requests for changes if desired.

These ordinances have the potential to affect your everyday life and is strongly suggested that you obtain a copy, read and participate in the process for approving them.

Unfortunately, the residents of Parkers Run and Stonington are contending with a "Lights Out" situation in their communities.

"Word on the street", is that the Town can and should pay the light bill and have the lights turned back on.

The truth of the matter is, both communities are considered


private and are under the license and control of their respective HOA's and the Town has no authority to pay the bill, because the streets do not belong to the Town.

The light bills for streets that are owned by the Town are paid with the assistance of a State grant known as Municipal Street Aid.

Funds from that account can only be used by streets that are owned by the Town.

The Council, however, is continuing to seek ways and means to assist both communities.

A few months ago, School Lane was re-paved to provide a better riding and driving surface.

Since that time, numerous complaints have been received concerning the ever increasing number of vehicles exceeding the speed limit on the street.

As a result a stop sign has been placed on the north east corner of Fulton Street and School Lane and two 25mph signs have been installed.

Unfortunately, these efforts may still not be enough to reduce the

number of complaints or the potential of an accident.

Therefore, the Mayor and Town Council are once again considering the idea of closing School Lane at the western end of the street before the entrance to Fox Pointe.

The history of School Lane indicates that it was never intended to be nor is it recorded as a through street.

The Town will engage in discussion with the Fire Department to determine the impact of once again



A letter has also been sent to Kent Construction requesting them to install a fence around the overflow parking lot off School Lane in anticipation of drivers using the overflow lot as a by-pass to the street being blocked.
