**ADOPTION OF ALL HAZARD MITIGATION PLAN FOR
THE TOWN OF CHESWOLD, KENT COUNTY, STATE OF DELAWARE**

Whereas; the Disaster Mitigation Act of 2000, as amended, requires that local government develop and adopt natural hazard mitigation plans in order to receive certain federal assistance, and


Whereas; a local Hazard Mitigation Advisory Committee comprised of County governmental departments, Municipal Council members, the business community, non-profit organizations, and citizens working in Kent County, of the State of Delaware, convened in order to study the Town of Cheswold's risks from and vulnerabilities to, natural, technological and terrorist threats, and to make recommendations on mitigating the effects of such hazards on the Town, and;

Whereas; a contract was issued to an experienced consulting firm to work with the Kent County Hazard Mitigation Advisory Committee, and the Delaware Emergency Management Agency, to develop a comprehensive all hazard plan for Kent County of the State of Delaware, and;

Whereas; the efforts of the Town of Cheswold, Kent County, and the consulting firm have resulted in the development of an all Hazard Mitigation Plan for the County and the Town of Cheswold,

Be it resolved, that the Town Council, of the Town of Cheswold, Kent County, Delaware; hereby approves and adopts the Kent County All Hazard Mitigation Plan, dated, October 13, 2015, for the Town of Cheswold and Kent County, of the State of Delaware. A copy of the plan is attached to this resolution.


