The meeting was called to order by Mayor Larence Kirby at 6:25 p.m., followed by the Pledge of Allegiance and a Moment of Silence.

The Mayor noted that the meeting posted on December 30, 2020 and properly recorded as late due to the vacation of the Town Secretary.

The Mayor then requested the Town Secretary, Mrs. Sam Callender, to complete a roll call of the Council. The following is the result of the roll call:

Town Administrator Callender presented the following Ordinance for public comment:

Ordinance 11-16-20-060 Ordinance for the adoption of the 2018 Building Code of the International Code Council - Purpose: To provide the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and use; and the condemnation of buildings and structures unfit for human occupancy and use, and the demolition of such existing structures in the Town of Cheswold; providing for the issuance of permits and collections of fees thereof.

Ordinance 11-16-20-061 Ordinance for the adoption of the 2018 Residential Code of the International Code Council - Purpose: To provide for the standards for regulating and governing the construction, alteration, movement, enlargement, replacement, repair, equipment, location, removal and demolition of detached one and two family dwellings and multiple single family dwellings, (townhouses), not more than three stories in height with separate means of egress as herein provided, and provides for the issuance of permits and collections of fees thereof.

Ordinance 11-16-20-062 Ordinance for the adoption of the 2018 Property Maintenance Code of the International Code Council -- Purpose: To provide for the standards for regulating and governing the condition and maintenance of all property, buildings and structures' by providing the standards for supplied utilities and facilities and other physical things and conditions essential to ensure that structures are safe, sanitary and fit for occupation and uses; and the condemnation of buildings and structures unfit for human occupancy and use, and the demolition of such existing structures in the Town of Cheswold; providing for the issuance of permits and collections of fees thereof, and each and all of the regulations, provisions, penalties, conditions and terms of said Property Maintenance Code.
