RESOLUTION OF THE ANNEXATION OF 5867 NORTH DUPONT HIGHWAY IN ACCORDANCE WITH THE CHARTER OF THE TOWN OF CHESWOLD

Whereas; the Charter of the Town of Cheswold, Section 3.1.1 and Section 3.2.1, authorizes the Town Council to consider requests from property owners to extend the boundaries of the said Town after notification of the property owners and the residents of the Town and the territory proposed to be annexed; and

Whereas; the Mayor and Council of the Town of Cheswold pursuant to the requirements of the Town Charter, deem it in the best interest of the Town of Cheswold to solicit public comment and opinion on the request for annexation of property described as 5867 North Dupont Highway, Map ID 4-00-03704-01-3200-00001, owned by Mr. Louis Ramunno, of 903 French Street, Wilmington, DE; and

Whereas; said parcels lie on the west side of North Dupont Highway, at the intersection of Route 13 and Messina Hill Road, and said parcel on the far west side is contiguously connected to the Town of Cheswold by its connection to Map ID 4-03-04602-08-9900-000, on the north side and Map ID's 4-03-04602-03-2700-000 and 4-03-04602-03-2600-000, all of which are a part of the Stonington Sub-division and previously annexed into the Town of Cheswold; and

Whereas; the Mayor and Town Council gave prior proper notification of the proposed annexation to the property owners and the residents of both the Town and the territory to be annexed upon adoption of this resolution; and

Whereas; such public comment was solicited, by the Town Council in a Public Hearing, held by the Town Council, before the regular Town Council Meeting on the 1st of October 2018, beginning at 6:00 p.m., in the Cheswold Fire Hall, 371 Main Street, Cheswold, DE 19936, regarding the proposed annexation of 5867 North Dupont Highway; and

Whereas; there were no objections or concerns voiced against the annexation, by any involved property owner or resident of the Town of Cheswold; and

Whereas; this annexation request was reviewed and accepted by the Office of State Planning Coordination along with a revision to the Town of Cheswold 2010 Comprehensive Plan to reflect the addition of residential housing and zoning to the five, (5), year Growth Plan and Map; and
