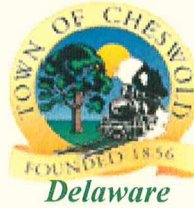

MONETARY APPROVAL LEVELS

WHEREAS; the Town Council of the Town of Cheswold, Delaware, is authorized and mandated by authority of the Town Charter, Section 4 to have and enjoy all powers possible for a municipal corporation to have under the Constitution and laws of the State of Delaware, as fully and completely as though they were specifically enumerated in the Charter, and;

WHEREAS, section 4.2.48 of the Charter provides the Council the authority to make, adapt, and establish, alter and amend all such Ordinances, Regulations, Rules and By-Laws not contrary to the laws of this State and the United States as the Town Council may deem necessary to carry into effect any provisions of the Charter or any other law of the State relating generally to municipal corporations or which they may deem proper and necessary for the order, protection and good government of the Town.....and;

WHEREAS, the Town Council on this day, June 6, 2016 has deemed it necessary for the timely and orderly review and approval of Town expenditures, the following monetary approval levels are hereby approved for the position titles, shown, without a majority approval vote of the Town Council:

<u>POSITION/TITLE</u>	<u>MAXIUM APPROVAL LEVEL</u>
Council Person	\$100.00
Town Administrator/Manager	\$250.00
Secretary/Treasurer	\$300.00
Vice-Mayor	\$400.00
Mayor	\$500.00

And WHEREAS, the Council additionally deems it necessary that expenditures exceeding \$500.00 must be approved prior to payment by a majority vote of the Town Council, and

WHEREAS, the Council also deems it necessary to continue the requirement for two, (2), signatures on Town checks, after the approval of the expenditure, with one signature being that of the Secretary/Treasurer and the other being any Councilperson having authority to do so, through the requirements of the Town Bank;

BE IT RESOLVED, that the Council of the Town of Cheswold, Delaware, by majority vote has approved and implemented the above maximum approval levels and signature requirements of all expenditure of funds through any and all accounts of the Town of Cheswold.
