**APPOINTMENT
of DINGLE & KANE, PA
TOWN of CHESWOLD ACCOUNTANT**

WHEREAS; the Town Council of the Town of Cheswold, Delaware, is authorized and mandated by authority of the Town Charter, Section 14 to retain a certified public accountant to be the auditor of accounts of the Town of Cheswold, and;

WHEREAS, the same section of the Charter defines the duties of the auditor to audit the accounts of the Town and of all of its officers whose duty involves the collection, custody and payment of monies to or by the Town, and;

WHEREAS, the same section of the Charter permits the auditor to have access to all records and accounts of the of the offices of the Town, and;

WHEREAS, the Council is directed in Section 6.2.3 of the Town of Cheswold Charter to provide an annual report of the financial condition of the Town showing its receipts and expenditures by a skilled auditor as the Town Council shall, by resolution select; and

BE IT RESOLVED, that the Council of the Town of Cheswold, Delaware, by majority vote has appointed the accounting and auditing firm of Dingle & Kane, PA, 356 East Main Street; Suite 100, Newark, Delaware 19711-7194, Phone: (302-731-5200); Fax: (302-731-8310), to perform such audits and to perform associated accountant duties as required for the Town of Cheswold, until such time as the agreement is severed by either party effective December 5, 2022; and

BE IT ADDITIONALLY RESOLVED, as directed by the Town Charter in Section 14.2, that the results of such audit be published in at least one newspaper of general circulation in the Town of Cheswold within thirty, (30), days of its receipt by the Town Council.
