**APPOINTMENT OF ERIC TEMPLE

Whereas: the major roles of the appointed officials is to prepare and revise the comprehensive plan and the review of development proposals; and

Whereas: the appointed officials will adhere to the rules and guidelines specified for planning in the Delaware Code – Title 22 and Title 29; and

Whereas: the appointed officials recognize and accept that they will function as technical consultants to the Town Council by recommending effective ways to accomplish the general community goals requested by the Council; and

Whereas: the appointed officials recognize and accept that the Town Council makes the final decisions with whatever political considerations it deems necessary; and

Whereas; the appointed officials recognize and accept that the Planning Commission works in conjunction with the Town Council, and that the Commission is a separate recommending unit;

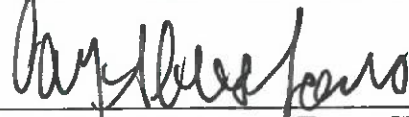
